PURPOSE STATEMENT

As a community of women created in the image of God, called to discipleship in Jesus Christ, and empowered by the Holy Spirit, we commit ourselves to grow in faith, affirm our gifts, support one another in our callings, engage in ministry and action, and promote healing and wholeness in the church, the society, and the world.

The North Carolina Synod Land Acknowledgement

The North Carolina Synod office is located on the original and ancestral homelands of the Catawba and Keyauwee people, and we acknowledge their presence here since time immemorial. We also wish to recognize and honor all our Indigenous siblings who have called and continue to call this land their home.

We honor and name those who lived here before the synod came to be, who were the first stewards of the land, the first people who offered the first prayers and sang the first songs into the very soil under our feet. All land has a tribal story. We must remember it as the first and current home to many Indigenous people. We recognize and confess that our ability to be working and living here now comes as a direct benefit of policies of expulsion and assimilation of Native American peoples.

The whole of the NC Synod stretches from the mountains to the coast of this state. Before any Lutheran movement, this land was made up of diverse, culturally-organized, and productive communities. There were 27 known tribes that inhabited this land at its beginning. We say their names: Chawanoke, Croatoan, Hatteras, Moratoc, Secotan, Weapemeoc, Machapunga, Pamlico, Coree, Neuse River, Tuscarora, Meherrin, Cherokee,

Cape Fear, Catawba, Shakori, Sissipahaw, Sugeree, Waccamaw, Waxhaw, Woccon, Cheraw, Eno, Keyauwee, Occaneechi, Saponi, and Tutelo.

We know that Native American peoples are not historical subjects but part of our communities, churches, schools, and leadership, and we give thanks for the invaluable wisdom they offer for the ways we exist, today and into the future, in relationship with Mother Earth and our human and non-human neighbors.

Currently, North Carolina has the largest
Native American population east of the
Mississippi River and the eighth-largest Native
American population in the United States.
The current tribes living on this land are:

Eastern Band of Cherokee (Swain County and surrounding counties)

Coharie (Sampson and Harnett counties)

Lumbee (Robeson and surrounding counties)

Haliwa-Saponi (Halifax and Warren counties)

Sappony (Person County)

Meherrin (Hertford and surrounding counties)

Occaneechi Band of Saponi Nation (Alamance and surrounding counties)

Waccamaw-Siouan (Columbus and Bladen counties)

The long history in this state of treaty negotiations, land use conflict, immigrant

settlement, and federal administration continues to this day. It is fundamental to remember this history and confess the injustice in order for us to move to healing and a more just future together. We must learn more, do more and realize healing and justice for Native American peoples whose lands we now occupy.

FROM THE DESK OF THE PRESIDENT:



Dear Sisters,

I pray you have had a wonderful Christmas, and that the Advent season has brought you joy, peace and a deep sense of God's love as we enter the new year.

I want to share several updates and important details for our upcoming work and opportunities to serve in the coming months:

Committee Day II will be held on January 18th at St. Marks, Mooresville. This is a key event for our committees to continue planning for 2025.

Here's a look at what some of the committees are working on:

- Annual Gathering to be held at Lenior Rhyne University on June 20-22.
- Discipleship Committee is finalizing plans for the One Day Retreat scheduled for either February 8 or 22. (see the brochure in this Bulletin for details)
- Justice committee continues to provide critical information and advocacy.
- Stewardship Committee continues to promote the "Supporting our Sisters" (SOS) program.
- Media/Outreach is a new committee focusing on enhancing our presence on FaceBook and the website.

I have included committee descriptions at the end of this letter. If you are interested in serving or have questions, please contact me.

Conference Leaders are actively working on the nominations for Vice President, Secretary, Board and Triennial delegates. If you feel called to serve, please know that the positions involve co-chairing a committee and committing to several meetings, including:

- Committee Day I &; II (with Board meetings following)
- A three-day training and planning session in July
- Board meetings in March and November involving overnight stays
- Board meeting before and after the Annual Gathering in June.
- Board members are also expected to attend Spring and Fall Conference Gatherings. Serving on the Board is an opportunity to build deep sisterhood and engage in meaningful work, and I encourage you to prayerfully consider these leadership roles. If you're interested in nominating yourself or someone else, please reach out to Susan Harris, our Nominations Chair, or contact me directly.

I want to make you aware of one other item. I received information from Churchwide WELCA in October. I brought this information to our Board meeting in November. We discussed the information at the meeting and are working diligently to pass our concerns along to Churchwide.

I feel that the Churchwide Board and our Interim Director are working to solve this problem and are keeping us informed. So, the following is the email that came to all Presidents:

Dear SWO Leaders,

The 2023 Audit Report indicates that expenses for the Women of the ELCA 2023 Triennial Convention and Gathering exceeded revenue by close to \$1 million.

Why did this occur?

The budget for the 2023 Triennial Convention and Gathering was built in 2018 for events that were to be held in 2020. Due to Covid, the Convention was rescheduled for 2021 and held on-line. When the 2023 Convention and Gathering was planned, the budget was not updated for inflation. In addition, smaller than anticipated numbers of participants for the 2023 Gathering resulted in less than expected revenue from registrations and higher than expected fees from the hotel and convention center.

How will this issue be resolved?

The Executive Board is working with the Interim Executive Director, staff, and the Office of the Treasurer of the ELCA to determine a payment plan for this debt from our investment (or endowment) resources. Your executive board is also working with the Interim Executive Director and staff to prepare a budget for the next triennial that does not create deeper debt.

An immediate decision was made by the Women of the ELCA Churchwide Executive Board meeting on Saturday, October 19, 2024, to reduce expenses for the 2026 Triennial Convention and Gathering by holding the Convention portion online.

The board evaluated the projected expenses to hold the Convention in-person in Des Moines, as well as virtually in Chicago at the Lutheran Center or virtually in Des Moines. Our Constitution requires that the churchwide organization fund the Triennial Convention. Knowing that we have a debt to repay for the expense overruns for the 2023 Triennial Gathering and Convention, we cannot intentionally add to that debt. The board voted to hold a virtual Convention in Des Moines, during the dates reserved for the event (July 13-15). The full executive board, the staff, the parliamentarian, and the 2026 elections committee will be present in person in one room communicating virtually with the voting members. Voting members from the synodical organizations will virtually join the convention proceedings. There will be no travel funded for synodical voting members for the 2026 Convention.

The Churchwide executive board encourages SWOs to begin thinking now how they might join their members with other voting members within regions to create mini in-person communities during the virtual Convention. We anticipate a one-day interim

between the virtual Convention and the opening of the Triennial Gathering to allow for travel to Des Moines for all who will attend the Gathering, scheduled to begin on July 16, 2026. We anticipate there will be pre-Convention virtual practice sessions for voting members to become familiar with the virtual voting process.

We will share additional information with you about our plans to repay the owed debt as well as our operating budget for the next fiscal year before December 31, 2024. Your executive board understands this decision may be viewed as a disappointment to the 2026 voting members, most of whom are yet to be elected in 2025. We trust that you have elected us to be good stewards of the resources we do have. We also value transparency in being honest with you about what we can and cannot afford to do as we move into the future.

Trusting the Holy Spirit to continue to lead us in our work together as we serve you.

- Stewardship: Encouraging faithful financial giving, offering life-planning resources, and managing the Synodical Constitution.
- Conference Leaders: Planning events and activities at the conference level and coordinating nominations for leadership positions.
- Annual Gathering, including securing presenters, planning worship, coordinating meals, and gathering evaluations.

Each of these committees plays a vital role in furthering the mission of Women of the ELCA, and your participation can help us fulfill God's work in our communities and beyond. For a final thought, as we begin the year, I encourage you to reflect on how you can grow in your part of this organization. Whether through prayer, action, or service, your involvement strengthens our sisterhood and helps us live out the mission we are called to fulfill. I look forward to seeing many of you at Committee Day II and to all the exciting opportunities in the months ahead. Our mission is to increase awareness of and access to essential hygiene items to promote dignity, health, and quality of life for the people of North Carolina.

Integrity

Mindful decision making

Creating a diaper bank model that can be shared, replicated, and adopted by all counties in North Carolina.

Improving access to personal hygiene products and other basic necessities to remove barriers to education, employment, or personal fulfillment.


Bring your ideas for our Spring Program to Committee Day.
